The foregoing persons are hereinafter sometimes collectively referred to as the "Reporting Persons". Any disclosures herein with respect to persons other than the Reporting Persons are made on information and belief after making inquiry to the appropriate party.

The Reporting Persons have entered into a Joint Filing Agreement, a copy of which is filed with this Schedule 13G as Exhibit 1, pursuant to which they have agreed to file this Schedule 13G jointly in accordance with the provisions of Rule 13d-1(k) of the Act.

Consequently, Boswell is the beneficial owner of 471,592 shares of Common Stock (the "Shares"). Ms. Gross, as the director of Boswell, has shared power to vote and/or dispose of the Shares beneficially owned by Boswell. Ms. Gross does not directly own the Shares. By reason of the provisions of Rule 13d-3 of the Act, Ms. Gross may be deemed to beneficially own the Shares beneficially owned by Boswell.
